



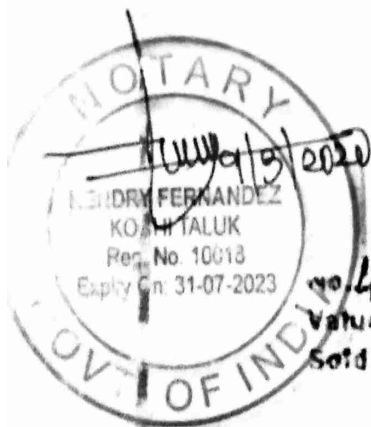

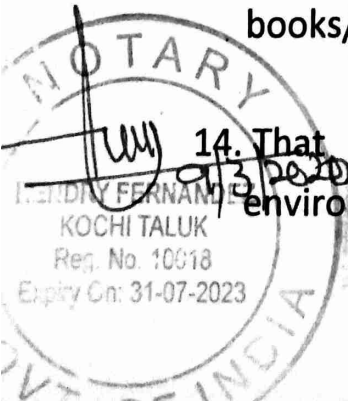

7. 17. That the school will not sponsor students from other Board.

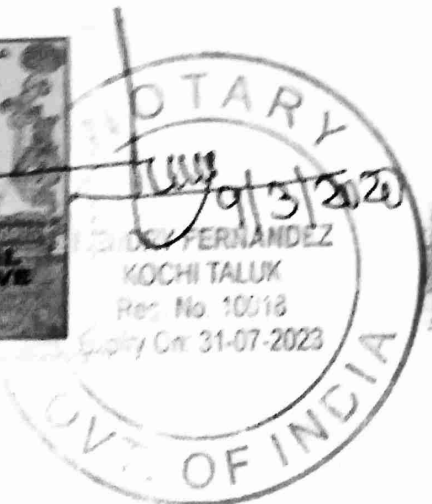
18. That no members of School Managing Committee is related to each other.
